Analemma Society (AS) is a 501 (c) 3 Educational Non-Profit dedicated to teaching the public science through Astronomy. AS is registered with the Commonwealth of Virginia. We maintained our status by doing our annual registration with the state as well as filing income tax forms with the US Internal Revenue Service. We are authorized by the state of Virginia to fund raise. We operated Observatory Park at Turner Farm to further our educational aims.

AS opened Observatory Park (OP) to the public for Friday night viewing and OP Saturdays and Sundays in general as in years past and closed when the sky was cloudy, temperature below 20° F, (or wind/chill factor below 20° F), or snow/ice on ground, OP was not opened to the public.

The AS opens OP to the public on clear weekends for sundial viewing and general unsupervised public access to the park. During the year work was done on the Remote Access Telescope Observatory (RATO) by Fairfax County Park Authority (FCPA) on the structure to repair water damage and improvements to prevent future damage. This was completed in mid-November.

During summer months AS (Robert Anderson, Rich Mascis, and Jeff Kretsch) has set up an outreach table at the Reston Farmer's Market Saturday mornings to advertise the park.

Analemma Society Members (Alan Figgatt, Peter Gural, Bill Burton, Gerald Kassalow, Calvin Powell, Bob Kellogg, Mary Blessing, Dan Ward and Jeff Kretsch) were active in supporting the Fairfax County Parktakes program with courses on meteors, telescopes, the moon, and family centered courses among other topics. We also hosted visits to the park by the National Geospatial-Intelligence Agency Alumni Association (NGAA) and other groups. There were 51 Parktakes sessions over the period of this report.

July 11, 2019 Bob Kellogg made a sundial presentation to the Ashburn Summer Library Program with support from Jeff Kretsch and Ashburn Library volunteers to children ages 4-6.

April-August 2019 AS monitored blue bird boxes at the Park and provided results to the Virginia Bluebird Society.

August 3, 2019 AS (Jeff Kretsch and Robert Anderson) supported a table at the 4H Fair and Carnival held at Frying Pan Park under Fairfax County Park Authority.

September 21, 2019 AS (Jeff Kretsch, Mary Blessing and Robert Anderson) held an Equinox Demonstration Event at the Park.

Membership Drive: Analemma Society collected <u>\$2,060</u> in dues and donations over this period.

Springvale Road Pickup: Springvale Road runs along the western boundary of the park, and to maintain a pleasant appearance and environment AS has been doing road pickup under the Virginia Department of Transportation (VDOT) Adopt a Highway program. We have been doing the pickups on a quarterly basis and reporting results to VDOT.
